

## Speaker Agreement

NOW, THEREFORE, for and in consideration of the mutual covenants below and other good and valuable consideration, the parties hereby agree as follows:

1. **Purpose.** The Speaker wishes to promote its products or services via the Company's properties, and to make a webinar or recorded presentation at a mutually-agreed upon date.
2. **Representations.** Speaker warrants that he or she is a subject matter expert on the topic, and is qualified to provide training and/or advice on the agreed-upon topic.
3. **Ownership.** Though the Company does not prohibit the Speaker from making similar presentations for him or herself or other third party, Speaker understands that the presentation, in live, recorded, or other format, (the "Work") is the property of the Company, and that no other party has any right, claim, or interest in the Work. The Company may, upon request, make available to the Speaker an audio file of their event for use on their website or other marketing materials.
4. **Responsibilities.** Where applicable, Speaker to provide topic title and teaser text at least 30 days in advance of the presentation's scheduled date, and a handout in .PDF, Word, or other agreed-upon format at least three days prior to the presentation date. Further, Speaker to be available for a training session on how to use the audio conferencing system; dial in for his or her scheduled presentation at least two minutes before the presentation's scheduled time, and; provide a professionally-acceptable presentation. Last, Speaker agrees to actively promote the Real Futures program via its website and other marketing methods.
5. **Speaker Payment.** Speaker to make payment to the Company according to the following schedule: \$995 for the branding and promotional opportunities, plus the presentation fee selected below. Payments due in full ten business days prior to scheduled presentation date.
